Keeping your information up to date:



As an Academy, we want to ensure we have the most up to date information on you and your child/children. Sims Parent Lite will provide parents with an effective, convenient and user friendly platform to access, review and request changes to the data the Academy holds. These changes can be made directly from your smartphone, tablet or PC on IOS, Android or via your browser. You will be able to provide additional information on crucial details such as medical information or dietary needs. When a change request is submitted by you, an alert is sent to the school office. Staff will review requests and update our student database, eliminating manual errors. Notifications will be sent to remind you to update your child's consents or parental consents throughout the year. Please note Sims Parent Lite will replace the annual TSOE3 paper form. The paper form will still be available from reception if needed.

Following the introduction of the General Data Protection Regulation (GDPR) in May 2018, schools have new requirements around the way they use student and parent data. **SIMS Parent Lite** helps schools comply with the new GDPR data requirements, by providing a simple way to collect, manage and handle information by obtaining accurate data securely from parents.

Getting Started:

We will send an activation email to your home email address. Simply click on the link from your tablet, pc or smartphone to activate your account. You can then login using your normal Facebook, Twitter, Google or Microsoft username and password. You will be able to see all children for whom you have parental responsibility on the app once registered, or you can easily create an account on any of the platforms.

The email will be from noreply@sims.co.uk in your Inbox. If not there, check in your Junk mail.


Once registered you can enter the Sims parent app by downloading this for free via the Apple store, Google play store (Android) or www.sims-parent.co.uk






By clicking on your child’s name parents/guardians can amend these details only – Medical details, Cultural information, Dietary needs, and Parental consents.




Parents/guardians can also amend their own details only by clicking on their name. Please make sure to confirm any changes made.



Please make sure any changes have been saved.



Parents/guardians need to ensure the Academy have the most up to date medical details in case of an emergency.



Security - Please be aware that Sims parent will remain active on your device unless you sign out. This can be done by visiting the menu at the top right of the homepage. Please also ensure you have adequate security settings on your device, for example a pass code.

Parents/guardians need to be aware what they are consenting to. Please see below.

School Visit - Parents/guardians give permission for their child/children to attend the following:

- Academy trips & other activities that take place away from the Academy sites during the school day
- All visits (including residential trips) which take place outside normal Academy hours including weekend and non-term times
- Adventure activities e.g. climbing, sailing, canoeing, ten tors
- Offsite sporting fixtures, tournaments and special events both within and outside of the normal Academy hours e.g. rugby fixtures and travel between the Borough Road and Waterleat Road sites during the school day and after hours

Photograph Student - Parents/guardians give permission for their child/children to be photographed/videoed, this includes:

- Academy promotional and marketing purposes
- Names being used in documents that can be accessed by members of the public e.g. newspaper articles, website or social media
- Academy activities, trips and events

Ability to Swim 50m - Can your child/children swim 50m unaided?

Court Order – Is there an active court order regarding your child/children?

Emergency Asthma Consent - Parents/guardians agree to and/or give permission for the following:

- My child has been diagnosed with asthma/has been prescribed an inhaler
- My child can receive salbutamol from an emergency inhaler held by the Academy for such emergencies (possibly displaying symptoms of asthma, and if their inhaler is not available or is unusable)
- My child can receive salbutamol from an emergency inhaler on offsite trips and visits, fixtures and events
- My child has a working in date inhaler, clearly labelled with their name, which they will bring with them to the Academy every day
- I will provide the Academy with my child/children's Asthma plan completed by their asthma nurse or doctor

Please note that the emergency inhaler can only be used by children who have been diagnosed with asthma and prescribed an inhaler, or who have been prescribed an inhaler for another condition.

Paracetamol Consent - Parents/guardians agree to and/or give permission for the following:

- Academy staff to administer paracetamol in the event of a headache or other pains
- My child to have the age appropriate dosage as required (quantity)
- I will inform the Academy if my child should no longer take paracetamol
- Academy staff to administer paracetamol within school or offsite (school trip/fixture)
- My child/children are capable of answering, if asked, whether or not they have had a paracetamol product earlier in the day
- I will supply paracetamol if my child requires it regularly
- I will supply paracetamol suspension if that is all my child can take

Internet Access - Parents/guardians give permission for their child/children to have controlled access to the internet and other information sources on a wide variety of topics for educational purposes only.

Please note: To guard against inappropriate material being accessed intentionally or by accident we use a filtered service provided by the Academy's broadband provider.

Relationships & Sex Education – Sex education has now become Relationships and Sex Education (RSE), signalling the growing consensus that children are entitled to more than just the biological facts. PSHE and RSE will support spiritual, moral, cultural, mental and physical development and

prepare students for the opportunities, responsibilities and experiences of life. The programme of study includes three core themes: Health and Wellbeing; Relationships; and Living in the Wider World - this covers topics such as financial education, personal health, personal wellbeing, social issues and drug awareness. By consenting, parents/guardians give permission for their child/children to attend the RSE (Relationship and Sex Education) aspects of PSHE.

Data Exchange and Copyright Permission – Parents/guardians agree to the following:

The Academy is a registered data controller with the information commissioner and is able to hold data for specific purposes in relation to your child's education. We have a duty to protect your information and will only hold data relevant to the education and well-being of your child. We will ensure that all data passed to us is reviewed on an annual basis or when any amendments are passed to us. There may be occasions when we are required by law to share data with the relevant local authority or the department for education. This consists mainly of statistical data or information relating to safeguarding and we have an appropriate legal basis to share this information without consent; information on such disclosures can be found on the Department for Education website.

Tetanus – My child/children have an up to date tetanus injection and it is within the 10 year timescale.

Emergency Consent - Parents/guardians give permission for emergency first aid to be administered on their child/children or other urgent medical treatment during any Academy related trip or activity. Please note we would always aim to contact parents in the first instance and only administer if necessary.

1. How do I download the app?

2. I can't find my account registration email. What should I do?

Please check your junk mail and ensure it has not been marked as SPAM. If you still have not received your account registration email, please contact the Academy directly to make sure the correct email address is on the system. sims@paigntonacademy.org

3. How do I log in? (Please refer to step by step guide)

Parents will have received an email invitation from the Academy directing them to complete the registration process for Sims Parent Lite.

Parents can access the Sims Parent website by going to <https://www.sims-parent.co.uk> or via the Sims Parent App.

Once the app is downloaded onto your device, click the icon and this will take you directly to the app.

4. I can't remember my password. What should I do?

Visit the website of your account provider (i.e. Microsoft, Google, Facebook or Twitter) and follow their instructions for resetting your password.

5. Do I need to register separately for each of my children attending the Academy?

No. When you sign in to Sims Parent Lite you will be able to see all your children displayed in one place.

6. Why can't I access the Sims Parent site or why does the page not load correctly?

Ensure your internet browser is up to date.

If your internet browser is up to date and you are still experiencing problems, please contact the Academy.

7. I have signed into Sims Parent lite before but I can't sign in now. What should I do?

Ensure you are logged in using the correct account (i.e. the account you used during the Sims Parent Lite registration process).

To sign out of an incorrect account, visit the account provider's website (e.g. Google, Facebook etc.) and sign out.

Close the browser completely. Open a new browser window and log in to Sims Parent, using the account details you used during the registration process.

Alternatively, try accessing Sims Parent Lite through a private browser window; this will ignore any other logged in accounts.

If you still cannot sign in to Sims Parent Lite having followed the advice in this section, please contact the Academy directly.

8. Why can't I open the data collection sheet for my child?

If the data collection sheet is not visible from Sims Parent Lite for your child, you may not meet the criteria required for submitting changes to your child's account. A registered child contact must live at the same address as the child in order to be eligible to make updates to the data collection sheet.

If you can see the data collection sheet but it is locked (a padlock icon will be displayed) the data collection sheet has been previously submitted and is waiting for the Academy staff to authorise and apply the changes. Once the changes have been applied, the data collection sheet will become available again.

9. How do I stop my child's other contacts seeing my contact details in the data collection sheet?

The Academy has set your contact details as hidden from the other contacts linked to your child's account. They will not be able to see, amend or access your details.
